SVAF Scholarship Program granted scholarships to 20 students for attendance at various Colleges and Vocational schools in 2018. Funds paid for tuition, books, fees and other related educational expenses. Students performance is monitored by reviewing each recipients GPA plus one-on-one interaction throughout the year with each student. Payment of scholarship funds are made two times a year to monitor student progress. To receive a scholarship each applicant must complete an application, obtain two reference letters, complete an essay on their educational goals and be interviewed by the SVAF Board of Directors who make the final decision on granting the scholarship.

2018 was the 35th annual SVAF Program for children and parents from the Alviso Community. Over 525 gifts and educational books were distributed to the children. All children and parents received a free photo with Santa Clause followed by a free lunch. The SVAF annual event includes a Resource Fair with 20 civic and business organizations in attendance providing information on environmental issues and other matters of interest to the Alviso Community. The Gardner Health Services Group participated again this year offering medical services and free flu shots.

This year SVAF again provided funding to ANT Swim School LLC for summer swim lessons and recreational swimming for all Alviso children at the Alviso Community Pool.

On June 17, 2014, the San Jose City Council approved a Planned Development Permit for Trammell Crow to develop the Midpoint @ 237 Office and Manufacturing Project in Alviso. On July 17, 2014, Organizacion Comunidad De Alviso and unincorporated association filed in the Santa Clara County Superior Court a verified Petition for Writ of Mandate seeking to set aside the City's approval.

On March 16, 2015, the parties to this Alviso Lawsuit, Trammell Crow Company, LLC, the City of San Jose and the Organizacion Comunidad De Alviso, agreed to dismiss the Lawsuit. As part of the Settlement Agreement between the Parties Trammell Crow Company agreed to pay a total of \$272,000 for construction of the Alviso Park. The Parties to the Agreement selected Santa Visits Alviso Foundation, a 501 [c] 3, to receive settlement funds and disburse those funds in accordance with the terms of the Settlement Agreement. The Agreement stipulated that within six months of dismissal of the Lawsuit if there has not been substantial progress toward construction of the Park as determined by the Santa Visits Alviso Foundation and after consultation with the City of San Jose and Trammell Crow Company then the funds could be used for other projects or amenities benefitting the Alviso Community as determined by Santa Visits Alvisio Foundation.

In early 2018 the Property was sold by Trammell Crow Company to Google LLC. At that time Trammell Crow elected to make the final payment of \$72,000 for construction of the Alviso Park as stipulated in the Settlement Agreement.

The full amount of \$272,000 for Park Development is being held in a cash fund with Vantage Wealth Management, LLC.
