SVAF Scholarship Program granted scholarships to 26 students for attendance at various Colleges and Vocational schools in 2019. Funds paid for tuition, books, fees and other related educational expenses. Student performance is monitored by reviewing each recipients GPA plus one-on-one interaction throughout the year with each student. Payment of scholarships are made two times a year to monitor student progress. To receive a scholarship each applicant must complete an application, obtain two reference letters, complete an essay on their educational goals and be interviewed by the SVAF Board of Directors who make the final decision on granting the scholarship.

4b (Code:) (Expenses \$ 9,034 including grants of \$ enen) (Revenue \$)
2019 was the 36th annual SVAF Christmas Program for children and parents from the Alviso Community. Over 400 gifts and educational books were distributed. In addition all children and parents receive a free photo with Santa Claus followed by a free lunch. The SVAF annual event includes a Resource Fair with 26 civic and business organizations in attendance this year providing information on environmental issues and other matters of interest to the Alviso Community. The Gardiner Health Services Group participated again this year offering medical services and free flu shots.

This year SVAF provided funding to ANT Swim School LLC for summer swim lessons and recreational swimming for all Alviso children at the Alviso Community Pool.
